

**City of Antigo Concession Stand Agreement**  
Antigo Lake Park Concession Stand  
Peaceful Valley Warming House Concession Stand

Stipulations and agreements of this contract are as follows:

1. A \$50.00 deposit and a \$50.00 resident or \$100.00 non-resident fee will be paid to the City of Antigo by the organization or individual requesting the facility. This deposit will be forfeited to the City of Antigo if said organization does not comply with the following rules:

- \_\_\_\_\_ a. Concession building, score booth and immediate surrounding area is clean and free of waste, garbage, debris, boxes, etc. at all times.
- \_\_\_\_\_ b. Any misuse or negligence resulting in the destruction of the buildings or its equipment will result in total forfeiture of deposit.
- \_\_\_\_\_ c. If repairs are required the deposit will be subtracted from the total cost of repairs.
- \_\_\_\_\_ d. The concession stand building will be emptied of merchandise 24 hours after the scheduled event is completed.

\_\_\_\_\_ 2. An inspection will be made of the facility prior to and immediately following the use of the facility by the Park, Cemetery and Recreation Supervisor and/or designee.

\_\_\_\_\_ 3. The City of Antigo is not responsible for the loss or destruction of personal items in the concession building.

\_\_\_\_\_ 4. A special class "B" retailer's license to sell fermented malt beverages must be completed and filed with the Clerk Treasurer's office if alcoholic beverages will be sold.

\_\_\_\_\_ 5. The building will be turned over to the requesting organization the day prior to the scheduled event Monday – Friday or on Friday for a weekend event.

\_\_\_\_\_ 6. The deposit will be refunded to the organization upon a final inspection and written approval from the Park, Cemetery and Recreation Supervisor and/or designee.

We have read and understand the above agreement. We have read and understand the park policies and regulations. We accept the responsibility to maintain the facility in its proper condition and are responsible to reimburse the City of Antigo for damages done to the facility.

**PLEASE NOTE:** There will be a **minimum fee of \$100.00 for non-emergency call-outs** to the Park and Recreation staff after hours. Please be sure to have the proper keys/information before your reservation date.
